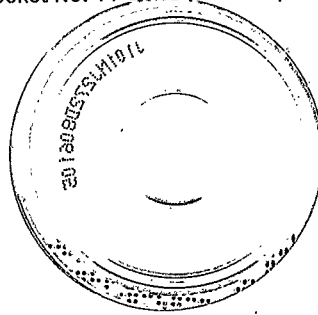

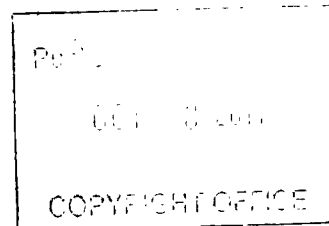

**PANDORA MEDIA, INC.'S NOTICE OF SUBMISSION OF CORRECTED PUBLIC
VERSION OF THE WRITTEN DIRECT TESTIMONY OF STEPHAN MCBRIDE**

Pandora Media, Inc. ("Pandora") hereby submits a corrected public version of the written direct testimony of Stephan McBride for the purpose of redacting one page that was inadvertently included without redaction as part of Pandora's public filing. Specifically, Table 1 to Mr. McBride's testimony, which contains the results of certain steering experiments conducted by Pandora (as described in Mr. McBride's testimony), was properly labeled as restricted in the margin pursuant to the protective order in the proceeding; the Table itself, however, was inadvertently left un-redacted in the public version of the filing. Pandora learned of this error only after the submission of its written direct statement. A corrected version of Mr. McBride's testimony with Table 1 properly redacted accompanies this motion, along with a corrected version of Pandora's redaction log. Pandora respectfully requests that the Judges replace the previously submitted public version of Mr. McBride's testimony with the corrected version, including on the CRB website.

Pandora will provide corrected version of Mr. McBride's public testimony to the other participants in the proceeding.
