**INDEPENDENT PRODUCERS GROUP'S NOTICE OF REVISED CLAIM
TO 2001 CABLE ROYALTIES (DEVOTIONAL)**

Worldwide Subsidy Group LLC (a Texas limited liability company) dba
Independent Producers Group ("IPG") hereby submits its *Notice of Revised Claim
to 2001 Cable Royalties (Devotional)*.

It was recently brought to the attention of IPG that IPG's Direct Statement,
filed April 15, 2016, erringly included an attribution of value for the 2001 claims
of Jack Van Impe Ministries and Salem Baptist Church. As reflected in IPG's
Direct Statement, IPG openly identified Jack Van Impe Ministries and Salem
Baptist Church as represented claimants in these remand proceedings (see Exh.
IPG-1) despite all 2000-2003 claims for such claimants, if made, having been
previously dismissed.

As a result of the foregoing, IPG's 2001 claim was overstated, and IPG hereby revises its 2001 claimed percentages in order to make claim to the following percentages of royalties:

2000	40.69%	59.31%
2001	42.32%	57.68%
2002	62.69%	37.31%
2003	63.66%	36.34%

Notwithstanding the foregoing, simultaneously herewith IPG has filed its *Motion for Reconsideration of Order Dismissing 2001 Claims of Jack Van Impe Ministries and Salem Baptist Church*. In the event that such motion is granted, this notice will be mooted, and IPG will seek the percentages originally set forth in IPG's Direct Statement.
