**ORDER GRANTING SETTLING DEVOTIONAL CLAIMANTS’ MOTION FOR FINAL  
DISTRIBUTION OF 2010-13 SATELLITE ROYALTY FUNDS**

This matter is before the Copyright Royalty Judges (Judges) on the motion of the Settling Devotional Claimants (SDC) for final distribution of royalty fees collected for satellite royalty years 2010 through 2013 that have been allocated to the Devotional category ([Motion](#)). The Judges previously resolved all distribution phase controversies regarding the SDC’s share of funds collected for satellite royalty years 2010 through 2013 in the Judges’ *Final Distribution Determination*, [83 Fed. Reg. 38,326](#) (Aug. 6, 2018), pursuant to an agreed resolution among the distribution phase parties. *See Multigroup Claimants’ Notice of Consent to 2010-2013 Cable and Satellite Shares Proposed by Settling Devotional Claimants, and Motion for Entry of Distribution Order (Jul. 11, 2019); [SDC Response to MGC’s Notice of Consent and Motion for Entry of Distribution Order](#) (Jul. 12, 2019).<sup>1</sup> No party appealed the Final Distribution Determination within the time permitted by 17 U.S.C. § 803(d). The Judges find that the confidential settlement agreement among all parties to the allocation phase of these consolidated proceedings ends any remaining controversy with regard to the subject funds.*

Therefore, pursuant to 17 U.S.C. § 801(b)(3)(A), the Judges **ORDER** final distribution of the SDC’s share of satellite royalty funds allocated to the Devotional category for satellite

royalty years 2010-2013 in amounts that the Licensing Division of the Copyright Office will compute in accordance with the Judges' Final Distribution Determination, 83 Fed. Reg. 38,326 (Aug. 6, 2018) and the confidential settlement agreement between all parties to the allocation phase of these proceedings, and allocating interest and expenses within the Devotional category as if the agreed distribution allocation set forth in the table in footnote 1 had been applied to each year's fund from the date funds were deposited until the date any portion of those funds was disbursed to the SDC (or from which Copyright Office expenses were deducted), with interest ceasing to accrue on funds when they were disbursed.

The Judges **ORDER** all parties to supply the Licensing Division with (a) the confidential allocation percentage share for each allocation phase category, (b) the amounts and dates of any partial distributions they have received from the 2010-2013 satellite royalty funds, and (c) such other information as the Licensing Division may require to make the necessary computations and to disburse the funds. All such information may be submitted to the Licensing Division under seal, without disclosure to the Judges. All pertinent information to effect the transfer of funds must be provided to the Licensing Division no later than February 27, 2020. The distribution shall take place on or after March 5, 2020.
