**SETTLING DEVOTIONAL CLAIMANTS’ NOTICE IN RESPONSE TO JUDGES’  
ORDER DIRECTING PARTIES TO REVIEW CALCULATIONS OF  
APPORTIONMENT OF INTEREST, AS IT RELATES TO REDACTION OF ORDER**

The Settling Devotional Claimants (“SDC”) hereby respond to the last paragraph of the Judges’ Order Directing Parties to Review Calculations of Apportionment of Accrued Interest [Restricted Version], directing the parties to identify by May 4, 2020, any material they propose to be redacted from the public version of the Order.

The Order itself, excluding its Appendix, does not appear to contain any Restricted information, and it should be filed publicly.

The SDC do not request redaction of the Appendix to the Order. However, because the calculations contained in the Appendix may contain information derived from a confidential settlement agreement between the Phase I parties in the 2000-03 cable royalty proceedings, the SDC request leave to serve the Appendix on the other Phase I parties so that the other Phase I parties may consider whether to request redactions from the public version.
