**SETTLING DEVOTIONAL CLAIMANTS' NOTICE OF PUBLIC FILING**

The Settling Devotional Claimants hereby give notice that they have publicly filed the public redacted version of their Notice in Response to the Judges' Order Directing Parties to Review Calculations of Apportionment of Accrued Interest), four business days following the filing of the public redacted version under seal. This is the Settling Devotional Claimants' best effort to comply both with eCRB filing procedures and with the Protective Order in this case, dated July 10, 2012, which predates the institution of eCRB. Paragraph 11 of the Protective Order provides:
