**[PROPOSED] FINAL DISTRIBUTION DETERMINATION
IN DEVOTIONAL CATEGORY**

This matter is before the Judges on the motion by Multigroup Claimants for entry of a consent order adopting the shares proposed by the Settling Devotional Claimants (“SDC”) in the Devotional category.

The Judges find based on the notice of Multigroup Claimants that there is no genuine dispute as to adoption of the SDC’s proposed shares, and that good cause exists for entry of a final distribution determination. It is hereby

ORDERED that the shares proposed in the SDC’s Written Direct Statement (Dec. 29, 2017) are adopted, and that final distribution of the cable and satellite royalty funds in the Devotional category are awarded in the following amounts:

2013	89.1%	10.9%

Devotional Satellite Fund

Satellite Royalty Year	SDC Share	MGC Share
2010	75.3%	24.7%
2011	88.3%	11.7%
2012	90.7%	9.3%
2013	97.7%	2.3%

This final determination determines the distribution of cable and satellite royalty funds for the years 2010 through 2013 in the Devotional category. The Librarian shall cause this final determination, and any correction thereto by the Register, to be published in the Federal Register no later than the conclusion of the 60-day review period.
