PBS JOINT CLAIM TO 2002 CABLE ROYALTIES

(This is a joint claim, pursuant to 37 CFR Part 252, to compulsory license fees for secondary transmissions under 17 USC §111 by cable systems during calendar year 2002. This claim is being filed by the Public Broadcasting Service (PBS) on behalf of itself and the licensees, operators, and managing agents of its member public television stations.)

1. THE FULL LEGAL NAME OF THE PERSON OR ENTITY ("CLAIMANT") CLAIMING COMPULSORY LICENSE FEES IS PUBLIC BROADCASTING SERVICE and licensees, operators, and managing agents of its member public television stations. (Attached is a list of the licensees, operators, managing agents, and stations that are included within this joint claim.) 
3. CONCISE STATEMENT OF THE AUTHORIZATION FOR THE FILING OF THE JOINT CLAIM: As members of PBS, all of the station licensees, operators, and managing agents on the attached list have collectively provided such authorization to PBS, through their elected PBS Board of Directors. Entities that are not members of PBS may nevertheless file valid, timely claims *individually*, in which they may declare themselves parties to the present joint claim and authorize PBS to represent them.


4. GENERAL STATEMENT OF THE NATURE OF THE COPYRIGHTED WORKS WHOSE SECONDARY TRANSMISSION PROVIDES THE BASIS OF THE CLAIM: Non-commercial public television programs (audio-visual works) and/or works included in such programming or its transmission.

5. IDENTIFICATION OF AT LEAST ONE SECONDARY TRANSMISSION ESTABLISHING A BASIS FOR THE CLAIM: The claimant owns the copyright, or exclusive rights under copyright, in the following programs: (i) THE AMERICAN EXPERIENCE show 1407: "Monkey Trial" (copyright owners: Nebraskans for Public Television Inc. and WGBH Educational Foundation [Boston, MA], both of which in turn granted exclusive telecast distribution or telecast rights to the Public Broadcasting Service and its member stations); (ii) STAGE ON SCREEN: "The Women" (copyright owner: Educational Broadcasting Corporation d/b/a Thirteen/WNET New York, which in turn granted exclusive telecast distribution or telecast rights to the Public Broadcasting Service and its member stations); (iii) LIFE 360 show 204: "Siblings" (copyright owner: Public Broadcasting Service); (iv) ZOBOOMAFOO show 220: "Crocodylian" (copyright owner: Public Broadcasting Service). To the best of knowledge and belief, those respective programs were broadcast on these dates in 2002: (i) February 19; (ii) June 18; (iii) August 19; (iv) November 8 at these times: (i) 2:30 AM Central; (ii) 9:00 PM Pacific; (iii) 8:00 PM Mountain; (iv) 3:00 PM Eastern by these non-commercial, analog, public television stations: (i) WTTW Chicago, Illinois; (ii) KCTS Seattle, Washington; (iii) KRMA Denver, Colorado; (iv) WHYY Wilmington, Delaware/ Philadelphia, Pennsylvania. To the best of knowledge and belief, those broadcasts, respectively, were retransmitted on a "distant-signal" basis by these cable operators: (i) Insight Communications; (ii) AT&T Broadband (now Comcast Cable); (iii) AT&T Broadband (which has since sold this system to Bresnan Communications); (iv) Comcast Cable to subscribers in these communities: (i) Monticello, Indiana; (ii) Bellingham, Washington; (iii) Sterling, Colorado; (iv) Wildwood/ Rio Grande, New Jersey. To the best of knowledge and belief, those communities are located outside the local service areas of the aforementioned, respective, retransmitted broadcast stations.
