Dear Claimant:

We received your claim for 1993 cable/satellite carrier royalties after August 1, 1994 and the envelope was dated only with a business meter. §252.4(c) of the Copyright Office regulations states "claims dates only with a business meter that are received after July 31 [August 1, this year] will not be accepted as having been timely filed."

However, §252.4(e) provides that "a claimant may nonetheless prove that a claim was properly mailed if it was sent by certified mail return receipt and the claimant can provide the receipt." In the future, you can avoid any question of when your claim was mailed if you have it postmarked by the U.S. Postal Service during the month of July.

New York - Fox's overnight rating for its first Sunday or regular-season NFL coverage was 18 percent higher than CBS' rating for the first weekend of the 1993 season.

Sunday's games on Fox got a 13.0 overnight rating and a 32 share, Nielsen Media Research said Monday. The rating is the percentage of televisions tuned in from 32 major markets and the share is the percentage watching among televisions in those markets that are on at the time.

National ratings will be released later this week.
