I. Comments on Existence of Controversy

In response to the Tribunal's August 7, 1991 Notice, on behalf of WFAA Television/A.H. Belo, Inc. ("Belo"), we advise the Copyright Royalty Tribunal that there have been preliminary discussions as to the distribution of Phase II royalties for the 1990 Satellite Carrier Copyright Royalty Distribution Proceeding, but there has been no final settlement. However, in light of the size of the 1990 pool, Belo supports consolidation of the 1990 proceeding with the 1989 proceeding.


II. Notice of Intent to Participate


