Claim to 1993 Cable Copyright Royalties

- I. **CLAIMANT:** Harron-Smith Television Partnership, licensee of television station KCCN-TV, Monterey, California.
- II. **ADDRESS OF CLAIMANT:** 2200 Garden Road, Monterey, CA 93940
- III. **PERIOD OF WHICH CLAIM IS MADE:** January 1 - December 31, 1993
- IV. **NATURE OF WORK FOR WHICH CLAIM IS FILED:**
 - (1) Examples of all station produced programming (including newscasts, public affairs, children's and sports programming) broadcast KCCN-TV, including but not limited to:
 - (a) Central Coast News at 5:30, 6:30 and 11.
 - (b) Central Coast News Weekend at 6:30.
 - (2) The station's entire broadcast day as a compilation.
 - (3) Syndicated programs for which KCCN-TV is the copyright holder of exclusive exhibition rights against other broadcast stations carried by a cable system in the KCCN market area as a distant retransmission, including but not limited to:
 - (a) Various off-network, made for TV syndicated programs by film and tape;
 - (b) Various motion pictures
 - (4) Sports events broadcast by KCCN-TV.
- V. **EXAMPLES OF DISTANT CABLE CARRIAGE IN 1993 (include at least one):**

"Central Coast News" was broadcast on KCCN-TV, Channel 46, licensed in the city of Monterey, California and retransmitted by TCI Cable of San Jose, serving the San Jose community.
