IV. NATURE OF WORK FOR WHICH CLAIM IS FILED

1. All station produced programming (including newscasts, public affairs and special events) broadcast by WVNY-TV, including but not limited to:

- a) "Newscenter 22" (Local Newscasts)
- b) "Forum 22" (Local Public Affairs)
- c) "Children First" (Local Public Affairs)
- d) "MDA Telethon" (National Telethon with Local Segments)
- e) "Children's Miracle Network Telethon" (National Telethon with Local Segments)

2. The station's entire broadcast day as a compilation.

3. Syndicated programs for which WVNY-TV is the copyright holder of exclusive exhibition rights against other broadcast stations carried by a cable system in the WVNY-TV market are as a distant retransmission, including but not limited to:

- a) Various off-network made for TV, syndicated programs by film and tape.
- b) Various motion pictures.

4. Sports events broadcast by WVNY-TV.

V. EXAMPLES OF DISTANT CABLE CARRIAGE IN 1995:

1. "Newscenter 22" was broadcast on WVNY-TV, Channel 22, licensed to the Burlington, Vermont/ Plattsburgh, New York market and retransmitted by Cablevision Industries, serving Hague, Hague Town, Silver Bay, in the county of Warren, New York, and Mineville, Moriah, Ticonderoga Village, Ticonderoga Town, and Witherbee in the county of Essex, New York, and Putnam, in the county of Washington, New York, on September 11, 1995 at 6:00 PM.

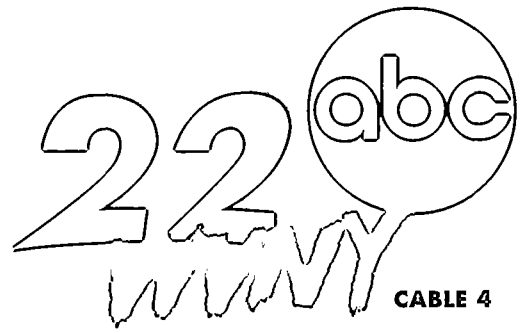

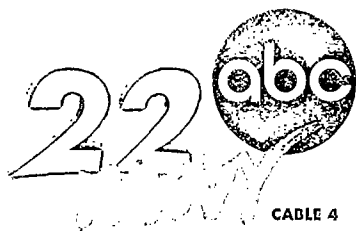

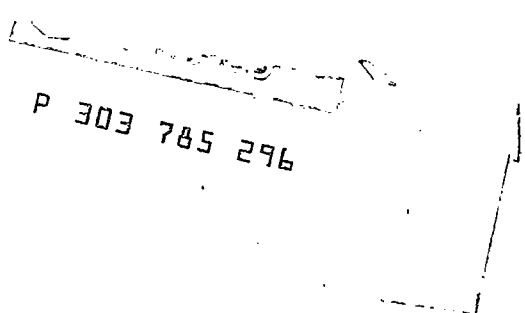
