**ORDER DENYING DAVID POWELL ADDITIONAL EXTENSION OF DEADLINE
FOR FILING RESPONSES IN OPPOSITION**

On June 10, 2020, Mr. David Powell, a *pro se* participant in the captioned proceedings, notified the Copyright Royalty Judges (Judges) by email that he continues to experience the technical difficulties that caused the Judges to extend the deadline for responding to the Joint Motions for Order to Show Cause Why the Claims of David Powell should not be Dismissed (Joint Motions)¹ from May 27 until June 8. *See generally Order Granting David Powell Extension of Deadline for Filing Responses in Opposition* (Jun. 2, 2020) ([Extension Order](#)).

On the previous day, June 9, 2020 (*i.e.*, one day after the extended deadline and one day before Mr. Powell's emails), the Judges, having received no further response from Mr. Powell, granted the Joint Motions and issued orders to show cause in the captioned cases. *See Order to Show Cause Why David Powell Should Not Be Dismissed*, Docket No. 16-CRB-0009 CD (2014-17) (Jun. 9, 2020) ([Order to Show Cause \(Cable\)](#)); *Order to Show Cause Why David Powell Should Not Be Dismissed*, Docket No. 16-CRB-0010 SD (2014-17) (Jun. 9, 2020) ([Order to Show Cause \(Satellite\)](#)).

To the extent that Mr. Powell's June 10th emails can be construed as a motion for an additional extension of time to respond to the Joint Motions, the motion is **DENIED** as **MOOT**. If Mr. Powell wishes to continue his participation in the captioned proceedings he must file his

responses to the *Order to Show Cause (Cable)* and *Order to Show Cause (Satellite)* within ten days from the date of those orders (*i.e.*, **no later than June 23, 2020**).
