**NOTICE OF CORRECTION TO MPA-REPRESENTED PROGRAM SUPPLIERS’
MOTION FOR FINAL DISTRIBUTION OF 2010-13 CABLE ROYALTY FUNDS**

On June 10, 2020, MPA-represented Program Suppliers (“MPA”) submitted their Motion For Final Distribution Of 2010-13 Cable Royalty Funds (“Motion”) to the Copyright Royalty Judges (“Judges”). It has come to MPA’s attention that there is a typographical error on page 2 of the Motion, in the table entitled “Allocation Phase Shares, Program Suppliers Category.” In that table, Program Suppliers’ Basic Fund Share should be listed as 19.3% for 2013, rather than 19.5%. *See* 84 Fed. Reg. 3552 (Feb. 12, 2019). MPA hereby provides notice to the Judges and the parties to this proceeding that their Motion should be corrected to reference the 2013 cable Basic Fund share awarded to Program Suppliers of 19.3%.
