**Regulation Concerning Proxy Distributions  
For Unmatched Royalties Deposited During  
2010-2018**

**Proposed Rule Comments**

Comments to Copyright Royalty Judges are proposing to amend their regulations concerning proxy distributions for unmatched royalties deposited pursuant to statutory license for the period 2010-2018. For Sound Exchange Inc., Board of Directors as and Collective sole source for statutory and compulsory license. Should not be the only interested party commenter to implement amended regulation change of action and proposal policy w/o giving the appearance of undue influences monopoly. Towards other commenters input as the only develop discretion on an ongoing basis authorization. To the rule making proposals rule for the judges to amend their regulations concerning proxy distributions BOD's of the Collective.

To amend part 370 Notice 37 CFR ss. 370.3 (i) , 370.4 (f), and 370.6 (b)(1) for judges to consider other claimants commenter statements. For judges authorization motion to implement regulations changes pertaining to amend ss. Part 370 revised authority citation develop discretion. To not only use the current proxy distribution methodologies but to authorized and add inserted other commenters amended proposal regulations. For proxy distributions going forward develop discretion with the BOD's of the Collective Sound

Exchange Inc. and agree with judges propose to use the permissive may to authorize such distributions. ss..370.6 (b)(1).

#### Regulations Concerning Proxy Distributions for unmatched Royalties

Deposited During 2010-2018. Commenter Petition the Judge to amend and adopt regulation proposal to use to permit Royalty Distribution for period 2010-2019 & or beyond. Authority citation Part 370 is revised to read as follows: Authority 17 USC 112 (e), 114 (f), 803 (b)(6)(A), amend ss. 370.3 by revising paragraph (i) to read as follows: may serve as the reports of use for the non-report service.

“To now include regardless of Pro se (David Powell d/b/a Circle God Network Inc., (members) status in any case proceedings entitled to royalties based on a data use Petition to Participate timely filed w/ Declaration in chief sworn statement signed proof. To received 5% recipient agent paid royalties each year by judges authorizing Sound Exchange to distribution to Pro se, and claimants members. For otherwise undistributable unmatched royalties annual / license type methodology using new Pro se proxy report of data use Petition to Participate claim. Solely for purpose of distribution of any corresponding royalties by the BOD’s of the Collective w/ or w/o approved of proxy data set 370.6(b)(1).”

Authority citation Part 370 is revised to read as follows: Authority 17 USC 112(e), 114 (f), 803 (b)(6)(A), amend ss. 370.4 by revising paragraph (f) to read as follows: may serve as the reports of use for the non-report service.

“ To now include regardless of Pro se David Powell d/b/a Circle God Network Inc., (members) status in any case proceedings entitled to royalties based on a data use Petition to Participate timely filed w/ Declaration in chief sworn statement signed proof. To received 5% recipient agent paid royalties each year by judges authorizing Sound Exchange BOD’s for the Collective to distribution to Pro se, and claimants members. For otherwise undistributable unmatched royalties annual / license type methodology using new revised Pro se proxy report data of use Petition to Participate claim.” Solely for purpose of distribution of any corresponding royalties by the BOD’s of the Collective w/ or w/o approved of proxy data set ss. 370.6 (b)(1).”

In addition to general comments regarding the proposal, the Judges seek comments on the following areas: 1) commenter agrees extend the current regulation for allocating royalties, no to judges regulation propose to permit but require Sound Exchange to use a proxy methodology, but propriety correctness to add commenter Pro se new required regulations proposal as 5% per year revised ss. 370.3 (i), 370.4 (f), paragraph and 370.6 (b)(1) proxy distribution w/ or w/o data set approved by Board of Directors of the Collective.

2) if not commenters respectfully require judges to authorize motion Sound Exchange BOD’s of the Collective to distribute 2010-2019 royalties 5% to Pro se claimant

recipient David Powell d/b/a Circle God Network Inc. (members) PTP and 95% to others participants w/o resorting to Proxy report of use.

3) Yes, means of distributing remaining royalties for this period if required authorized only w/ new revised paragraph w/ Pro se Petition to Participate 5% royalties for recipient David Powell d/b/a CGN Inc. (members) revised Part 370 370.3 (i), 370.4 (f) fair and appropriate. A better alternative is a 5% per year to Pro se recipient David Powell d/b/a CGN Inc. (members) PTP and 95% remaining to other participants. Then add David Powell to BOD's of the Collective revised ss. 370.6 (b)(1) proxy distributions revised.
