**MPA AND JSC NOTICE REGARDING RESTRICTED
APPENDIX TO MAY 1 ORDER**

The Motion Picture Association, Inc. (“MPA”) and Joint Sports Claimants (“JSC”) hereby submit this notice in response the Copyright Royalty Judges’ (“Judges”) September 23, 2020 *Order Granting The Settling Devotional Claimants Leave To Disclose Restricted Appendix To MPA-Represented Program Suppliers And The Joint Sports Claimants* (“September 23 Order”), which granted MPA and JSC leave to notify the Judges whether any information in the Restricted Appendix to their May 1, 2020 *Order Directing Parties to Review Calculations of Apportionment of Accrued Interest* (“May 1 Order”) should be deemed restricted information subject to the Protective Order issued in this proceeding, and redacted from the public version of the document. *See* September 23 Order at 2-3.

Counsel for the Settling Devotional Claimants disclosed the Restricted Appendix to the May 1 Order to MPA and JSC on September 23, 2020. MPA and JSC have reviewed the Restricted Appendix, and have concluded that there is no information in the document that should be deemed restricted under the Protective Order issued in this proceeding. Accordingly, MPA and JSC hereby notify the Judges that they do not propose that any information in the Restricted Appendix be redacted from the public version of the document.
