The Joint Sports Claimants (“JSC”) submit this notice in response to the Copyright Royalty Judges’ (“Judges”) October 14, 2020 *Order Directing Parties to Review Calculations of Final Distribution Shares* (“October 14 Order”). JSC has reviewed the Licensing Division calculations set forth in Appendix A to the October 14 Order, and does not seek clarification of any element of the calculations set forth therein.<sup>1</sup> JSC therefore encourages the Judges to distribute the 2010-13 cable royalty funds promptly and in accordance with Appendix A.
