Declaration and Certification of J. Blake Cunningham

1. I am counsel for Google LLC in the above-captioned case. I submit declaration and certification pursuant to Rule 350.4(e)(1) of the Copyright Royalty Judges Rules and Procedures, and per the terms of the Protective Order issued July 28, 2016, in support of the Third Supplemental Written Remand Testimony of Google Expert Greg Leonard. I am authorized by Google to submit this Declaration.

2. I, or those working under my supervision, are familiar with the Report submitted today, and I have reviewed the definitions and terms provided in the Protective Order. After consultation with my client and personnel working under my supervision, I have determined that to the best of my knowledge, information, and belief, the Testimony contains information that is proprietary, not available to the public, and commercially sensitive. If disclosed, this material would competitively disadvantage Google or provide a competitive advantage to another party.

3. The Restricted materials includes descriptions of the terms of license agreements subject to confidentiality obligations, as well as descriptions of Google financial performance and accounting.

4. Under Rule 350.4(e)(1), I therefore declare that to the best of my knowledge, information, and belief, the material in the documents produced with the "Restricted" label meet the definition in the Protective Order.

5. The information designated as “Restricted” must be treated as restricted “Protected Material” to prevent business and competitive harm that would result from the disclosure of such information while, at the same time, enabling Google to provide the Copyright Royalty Judges with the most complete record possible on which to base their determination in this proceeding.
