

Re: 1991 Satellite Royalty Proceeding

Dear Mr. Cannings:

This will respond to your May 26, 1993 letter concerning the distribution of royalties paid by satellite carriers pursuant to Section 119 of the Copyright Act.

(1) The Copyright Royalty Tribunal wired the 1991 satellite carrier royalties to the Major League Central Fund on January 12, 1993. The Major League Central Fund wired the Music Claimants their share of the royalties on January 13, 1993.

(2) The royalties were distributed pursuant to settlement agreements among the parties which had appeared before the Tribunal. A condition of those agreements is that the parties will not publicly disclose their respective shares.
