COMMENTS ON DISTRIBUTION OF ROYALTIES

The Joint Network Parties ("Networks") and the Copyright Owners are pleased to inform the Tribunal that they have reached a settlement concerning distribution of the 1989-1991 satellite carrier royalties. That settlement resolves the last remaining controversy regarding distribution of the satellite carrier royalty funds for those years. The Tribunal should, therefore, promptly distribute all royalties.

Copyright Owners, PBS, and the Networks have agreed that all 1989-1991 satellite carrier royalties should be distributed to a single agent. Agreement as to the proportionate allocation of royalties and designation of a common agent to receive payment on behalf of settling parties are permitted by Section 119(b)(4)(A). All parties support such provisions as necessary for achieving settlements without prejudicing positions that may be taken in future proceedings..

The parties move for prompt distribution of all 1989-1991 satellite carrier royalties to their common agent on the basis that no controversy exists regarding the allocation of those funds among the parties.


