MOTION FOR DISTRIBUTION OF
UNDISTRIBUTED SATELLITE CARRIER ROYALTY FUNDS

Program Suppliers, Joint Sports Claimants, Broadcaster Claimants Group, Public Television Claimants, Devotional Claimants, the National Broadcasting Company, Inc., ABC, Inc., CBS, Inc., the American Society of Composers, Authors and Publishers, SESAC, Inc., and Broadcast Music, Inc. (collectively "Copyright Owners"), pursuant to 17 U.S.C. § 119(b)(4)(C), hereby move for distribution of undistributed satellite carrier royalties in the aggregated amount of approximately \$4,200 for the years 1989 and 1991. Copyright Owners request that the satellite carrier royalties be used to pay any additional CARP expenses incurred in the current rate adjustment proceeding. In support of this motion, Copyright Owners state:

1. According to Program Suppliers' records, \$2,526 of 1989 satellite carrier royalties and \$1,650 of 1991 satellite carrier royalties, for a total of \$4,176, are currently undistributed. Copyright Owners ask that the full amount be sent directly to the Copyright Owners' agent for use in paying the Owners' share of the CARP expense for the current Section 119 rate adjustment proceeding.


2. Because all the owner groups entitled to receive 1989 and 1991 satellite carrier royalties are participating in the current

rate adjustment case, distribution in this manner offers a simple and efficient means to distribute these funds.


