
**ORDER GRANTING CLAIMANTS' REQUEST FOR FINAL DISTRIBUTION OF 2006
DART MUSICAL WORKS FUND ROYALTIES**

On February 3, 2014, Broadcast Music, Inc., the American Society of Composers, Authors and Publishers, SESAC, Inc., and the Harry Fox Agency, Inc. ("Settling Claimants") filed with the Copyright Royalty Judges ("Judges") a motion requesting distribution of the remaining 5% of royalties in the 2006 Digital Audio Recording Technologies ("DART") Musical Works Fund, both the Writers and Publishers Subfunds. The motion, which was unopposed, was filed subsequent to the Judges' January 15, 2014 order concluding that no controversy exists with regard to the 2006 DART Musical Works Fund royalties.¹

In light of the Judges' conclusion that no controversy exists with respect to the 2006 DART Musical Works Fund, the Settling Claimants' request for a final distribution of those funds (both the Writers and Publishers Subfunds) is **GRANTED**.

All pertinent information to effect the transfer of funds must be provided to the Licensing Division of the Copyright Office no later than March 13, 2014. The distribution shall take place on or after March 20, 2014.
