**Title 37: Patents, Trademarks, and Copyrights**  
PART 350 | GENERAL ADMINISTRATIVE PROVISIONS  
**§ 350.4 Filing and service.**

(a) *Filing of pleadings.* For all filings, the submitting party shall deliver ***an original, five paper copies, and one electronic copy in Portable Document Format (PDF) on compact disk (an optical data storage medium such as a CD-ROM, CD-R or CD-RW)*** or floppy diskette to the Copyright Royalty Board in accordance with the provisions set forth in §301.2 of this chapter. In no case shall a party tender any document by facsimile transmission, except with the prior express authorization of the Copyright Royalty Judges.
