**JOINT PETITION TO PARTICIPATE AND
COMMENTS OF THE CANADIAN CLAIMANTS GROUP**

The Canadian Claimants Group (“CCG”) submits this Petition to Participate in response to the notice published at 84 Fed. Reg. 2930 (February 8, 2019) (“Notice”). The CCG intends to participate fully and in good faith in the 2014-2017 Allocation and Distribution Phases of this proceeding. The CCG also submits a filing fee of \$150.00.

The CCG has existed as an Allocation Phase (previously Phase I) claimant group throughout most of the history of these cable royalty distribution proceedings and collects and distributes royalties to its members for non-American programming broadcast on Canadian television stations that were secondarily transmitted by cable systems in the United States pursuant to the cable compulsory license.¹ 17 U.S.C. 111. The CCG represents the majority of the programming on distantly retransmitted Canadian television stations during 2014 through 2017 and thus has a significant interest in the royalty funds at issue.

The CCG includes members who filed joint claims to the 2014-2017 cable royalties and members who filed individual royalty claims but have entered into agreements to be members of

the CCG. The joint claims and the membership agreements designate the Canadian Broadcasting Corporation as the authorized representative of the CCG and the undersigned has been designated as counsel for the CCG. In accordance with 37 C.F.R. § 351(b), the CCG attaches a list of all participants in this joint petition as Attachment A hereto.²

Some members of the CCG may also be eligible to collect royalties from other Allocation Phase claimant groups because their programming was broadcast on distant U.S. commercial or U.S. public television stations, but the CCG does not represent those members in Distribution Phase proceedings. With the exception of the Canadian Broadcasting Corporation/Radio-Canada, the CCG is unable to provide categorization of its constituent claimants' entitlement to make claims in other program categories. The CBC/Radio-Canada has designated Distribution Phase claims in the Program Suppliers, Public Television Claimants and Public Radio categories.

The CCG is currently aware that a controversy may exist within its Allocation Phase category as to the distribution of any royalties awarded to the CCG for the years 2015-2017. In response to the Copyright Royalty Judges' request for comments on the existence and extent of controversies to 2014-2017 cable royalties, as published in the Federal Register on November 9, 2018 (83 Fed. Reg. 56106), Multigroup Claimants (as self-styled successor in interest to the Independent Producers Group) ("MC") informed the Judges of its position that a controversy exists between MC and the CCG. Therefore, the CCG intends to participate in the Distribution Phase to resolve that controversy, as well as any other Distribution Phase controversies that are identified involving distribution of any Allocation Phase award to the CCG for the 2014-2017

cable royalty years.
