The facts in support of this motion follow.

Pursuant to 37 C.F.R. 251.45(a), an entity intending to participate in the CARP proceeding must file a Notice of Intention to Participate ("Notice"). Pursuant to Fed. Reg. 56,941 (2000), such notices were to have been filed with the Office of the General Counsel, Copyright Office, by Friday, October 13, 2000.

Due to unanticipated business obligations, the responsible corporate official at Entercom was unable to make contact with the undersigned authorized

representative in order to authorize the filing of the Notice in time to meet the October 13, 2000 filing deadline.

Considering that the October 13th notices to participate in the CARP were only recently processed at the Copyright Office, no entity is or will be prejudiced in any way by the relief requested by this motion and there will be no disruption in the proceeding caused by allowing this party to participate. A copy of a Notice of Intention to Participate in the CARP Proceeding on behalf of Entercom is attached hereto.

In light of the above, the instant request complies in all respects with the governing standards for motions of this nature, as set forth in the Order of the Copyright Office dated November 30, 1999. 


