**MUSIC CLAIMANTS' SUPPLEMENT TO JOINT PETITION TO PARTICIPATE**

Pursuant to 37 C.F.R. § 351.1(b)(2)(ii) and in response to the August 13, 2024 notice of the Copyright Royalty Judges (the “Judges”) published at 89 Fed. Reg. 64938 (Aug. 13, 2024) (the “Notice”), Broadcast Music, Inc. (“BMI”), the American Society of Composers, Authors and Publishers (“ASCAP”), and SESAC Performing Rights, LLC (“SESAC” and, together with BMI and ASCAP, “Music Claimants”) hereby submit Music Claimants’ Supplement to Joint Petition to Participate in the Allocation Phase and Distribution Phase of the above-captioned distribution proceeding for the 2018-2021 Satellite royalty funds (the “Proceeding”).
