**BROADCASTER CLAIMANTS GROUP'S MOTION FOR LEAVE TO AMEND  
PETITION TO PARTICIPATE**

The Broadcaster Claimants Group (“BCG”) respectfully requests leave to amend the Commercial Television Claimants’ (“CTV”) Petition to Participate in this proceeding for the limited purpose of submitting a complete and accurate CTV claimants list and claims data. Due to an unforeseen data migration failure that occurred during the original filing of the CTV Petition to Participate, the CTV claimants list that was uploaded through eCRB was incomplete and included errors that BCG would like to correct at this early stage of the proceeding.

BCG timely submitted the CTV Petition to Participate in *In re Distribution of Satellite Royalty Funds*, Docket No. 19-CRB-0011-SD (2018-2021) on September 12, 2024. Claimants filing a joint petition are required to upload an Excel spreadsheet in the eCRB online form that includes a list of claimants included in their joint Petition to Participate. The Excel spreadsheet was unfortunately incomplete at the time of filing, due to what CTV now understands to be a data migration issue. To create the Excel spreadsheet for the CTV Petition to Participate, BCG needs to migrate the relevant data from a separately maintained database console to Excel. On the date of filing, BCG experienced significant unanticipated data migration errors that we were unable to correct before the filing deadline. Based upon our investigation of the programming files and database console after the CTV Petition to Participate was filed, it appears that scripts embedded

in the database console caused conflicts with the data indexing in the output files that resulted in both duplication and deletion of certain data fields.

As a result of these errors, BCG was able to upload in the Excel file submitted with the CTV Petition to Participate a list of CTV claimants it represents only for the 2018 satellite royalty year, and not the list of CTV claimants it also represents for the 2019, 2020 and 2021 satellite royalty years.

The complete list of CTV claimants and claims data that BCG seeks leave to include in the CTV Petition to Participate is attached as Exhibit A. After removing the embedded scripts from the database console and suppressing certain data fields, this complete list of CTV claimants and claims data was successfully and accurately migrated from the database console, as such information existed on the date the CTV Petition to Participate was originally filed on September 12, 2024. A comparison version showing the amendments made to the CTV claimants list that was uploaded with the CTV Petition to Participate is attached as Exhibit B. For the purpose of creating a comparison version that accurately reflects the amendments made, the rows and columns of the as-filed claimants list were reordered to align with the rows and columns in the amended claimants list. Each of the CTV claimants included in the CTV claimants list in Exhibit A filed a timely copyright royalty claim with the Copyright Office, and each CTV claimant has authorized BCG to represent it in connection with the 2018-21 satellite royalty claims.

No party will be prejudiced by the Judges' granting BCG leave to amend the CTV Petition to Participate to include a complete and accurate CTV claimants list. First, BCG is, and has been since the first satellite proceeding, the sole representative of the CTV claimants included in Exhibit A and there is no known dispute with any other claimant representative as to BCG's representation of such CTV claimants. Second, this distribution proceeding is at its earliest stage with the

mandatory settlement period having not yet commenced. As such, there has been no detrimental reliance by any other party on the incomplete and inaccurate CTV claimants list uploaded with the CTV Petition to Participate filed one week ago. In addition, the administrative purpose of the Petition to Participate process is well served by ensuring that complete and accurate claimants lists and claims data are identified in Petitions to Participate filed in this proceeding for royalty claims timely filed by copyright owners.

### **CONCLUSION**

For the foregoing reasons, BCG respectfully requests that the Judges grant BCG's motion, and permit BCG to amend the CTV Petition to Participate to include the complete and updated list of CTV claimants and claims data as set forth in Exhibit A.
