**ORDER 3 CLARIFYING ORDER 2 ADDRESSING
OVERPAYMENT AND SURPLUS ISSUES**

On December 18, 2024, the Copyright Royalty Judges (Judges) issued an order (Order 2, eCRB no. 44285) directing each participant to provide the Judges, no later than January 8, 2025, in a filing made through eCRB to be designated/restricted for *in camera* review, the following detailed information regarding each partial distribution payment ultimately received by each participant in the captioned proceeding as well as all underlying proceedings:

- The amount of the payment made by the Copyright Office (Licensing Section);
- The participant to whom the payment was made;
- The participant to whom the payment was attributable;
- The amount of the payment attributable to the participant;
- The date the payment was issued;
- The annual fund year from which each above referenced payment was made; and
- The fund category for which each above referenced payment was made.

Furthermore, the Judges Ordered that, no later than January 8, 2025, each participant is to provide to the Judges, in the same filing manner as set forth above, copies of all signed repayment agreements addressing the funds in the consolidated proceeding, along with updated contact information for the parties to each agreement (and representatives of the parties).

To the extent the Copyright Office’s Licensing Section informs the Judges that additional information is needed to effectuate the recovery of royalty funds, the Judges may supplement this Order and Order 2 as appropriate.

The Judges hereby **CLARIFY** that the **ORDERED** actions set forth in Order 2 apply to all participants, including interested parties, all claimants and claimant representatives who received distributions in the captioned proceeding, and underlying proceedings (including related proceedings and proceeding phases). This Order applies whether or not such participants, parties, claimants and their representatives have previously provided this information to the Judges or the Copyright Office’s Licensing Section. Furthermore, the Judges hereby **ORDER** that the “Parties” in the captioned proceeding, as reflected on eCRB Docket 2012-6 CRB CD 2004-2009, shall collaborate to jointly serve this Order 3 and Order 2 on all relevant persons and entities indicated in this paragraph and confirm such service to the Judges, in a filing made through eCRB, no later than December 27, 2024.
