("SESAC"), pursuant to 17 U.S.C. § 111 ("Section 111") and 37 C.F.R. § 351.1(b), and in response to the Copyright Royalty Judges' Notice announcing commencement of distribution proceedings regarding 2010, 2011, and 2012 cable royalty funds (79 Fed. Reg. 76396 (December 22, 2014)), hereby submits its Petition to Participate in the above-referenced matter on behalf of its affiliated songwriters, composers, and music publishers whose works are publicly performed pursuant to the Section 111 cable service statutory license.
