Dear Sir or Madam,

This firm represents copyright holder Hearst Stations, Inc., and specifically WNNE-TV and WAPT-TV. I am writing with respect to the 2010 Satellite Retransmission Royalty Filings made by Hearst on July 29, 2011, copies of which I have attached to this email.

As you will see from the attached documents, we timely filed a correct claim for WNNE at 10:23 a.m. on July 29, 2011. Just a few minutes later at 10:39 a.m., in attempting to submit a filing for WAPT, we inadvertently included information in that (WAPT) claim referencing WNNE. To correct that inadvertent error, at 10:40 a.m., we then filed a corrected claim for WAPT.

Unfortunately, it appears that the Copyright Royalty Board has listed the second filing - - from 10:39 a.m. -- as the claim for WNNE, rather than the initial filing from 10:23 a.m. Because the 10:39 filing was in error, we respectfully request that the Copyright Board simply ignore this filing and list the 10:23 filing for WNNE and the 10:40 filing for WAPT as the correct claims.

Of course, if we need to make an amended filing, please let us know the protocol for doing so, and we will take care of it. If, by chance, the original, correct WNNE claim can merely be substituted into the Copyright Royalty Board's record, that would be great.

I hope this email explains the situation. I'm happy to answer any questions you may have so we can resolve this issue, and I thank you very much for your help.

Attached, you'll find (1) the confirmation receipt we received for the properly submitted WNNE claim; (2) the confirmation receipt we received for the properly submitted WAPT claim; and (3) copies of both the improper 10:39 a.m. WNNE claim and the proper 10:40 a.m. WAPT claim.
