The cities must be different..See attached form instructions - Important Claim Information (paragraph 3) "For the work to be considered a distant signal, the city of the primary transmission cannot be the same as the community in which the signal was retransmitted. When providing your example of a distant signal retransmission, you must clearly state the city and state in which the work was transmitted as a primary signal and where it was retransmitted as a distant signal"
