

**MOTION FOR DISTRIBUTION OF THE REMAINING 2%
OF THE 2010 FEATURED ARTIST AND SOUND RECORDINGS FUNDS**

On August 26th, 2011, Treasa Fennie */ Write 4 U Publishing (Write 4 U) filed with the Copyright Royalty Judges an Amended Motion " Write 4 U in Opposition to AARC's Inflated Demand for 98% of DART Royalties and Request further proceedings pursuant to R. section 801(b)(3)(C)". In its Motion, Write 4 U represents that the statistical data that AARC submitted to support its request underestimated the number of units that Ms. Fennie sold in 2010. Featured credit for song entitled " Young Heart, " was wrongfully attributed to Sandy Rivera (dba) Kings Of Tomorrow. Finally, Ms. Fennie contends that AARC is an "Interested Party" pursuant to 17 U.S.C. section 1001(D)(i) and 1007(a) (1)(2). On August 24, 2011, by email Herman Kelly (dba) Afterschool Publishing Co. declared himself a "Settling Party". On November 17, 2011, James Scott Sledge, Chief U.S. Copyright Royalty Judge granted an order to AARC "Settling Parties" request for partial distribution of 2010 Dart Sound Recording Funds. Wherefore, pursuant to section 801 (b)(3)(A) on the grounds that no controversy exist, Therefore, Treasa Fennie (dba) Write 4 U request all of the remaining 2% of the 2010 Dart Distribution.
