JOINT PROPOSAL ON REDACTED PUBLIC VERSION OF ORDER 52

On March 28, 2025, the Judges issued Order 52 Granting in Part Joint Motion For Further Distribution Of 2015-2017 Satellite Royalties (“Order 52”). Pursuant to Order 52, Commercial Television Claimants, Global Music Rights LLC, Joint Sports Claimants, Multigroup Claimants, Music Claimants,¹ Program Suppliers, and Settling Devotional Claimants (the “Parties”) have conferred, hereby submit that they have only one proposed redaction to Order 52, as follows:

- On page 4 of Order 52, in the last full sentence at the bottom of the page, the Parties propose that Program Suppliers’ settlement share of the 2015-2017 satellite royalty funds be redacted, so that the sentence reads as follows:

“Therefore, MGC asserts that the entire Program Suppliers fund (█% of the total fund) is in controversy.”

The Parties confirm that they have no further proposed redactions to Order 52.
