**DEVOTIONAL CLAIMANTS' OPPOSITION TO
MPAA'S MOTION TO CONSOLIDATE PROCEEDINGS**

On behalf of the Devotional Claimants, we submit these comments in opposition to the motion of the MPAA-Represented Program Suppliers to consolidate the 2010-2012 Phase I cable and satellite royalty proceedings.

First, the Devotionals Claimants endorse the comments of the Cable-Only Claimants. These parties have no statutory claim to satellite royalties and, rather than promoting administrative efficiency, consolidating the cable claims of these parties with the satellite claims of others would needlessly complicate the handling of these cases for these parties and all remaining Phase I entities.

Second, the joint letter filed by certain Phase I Claimants on January 27, 2015, sets forth the substantial reasons why consolidation is not warranted in this matter. MPAA has not rebutted any of those considerations, and has failed to meet its burden to show why consolidation is appropriate here. It should be underscored that the Phase I satellite parties have a very long

record of successfully resolving satellite claims without need for a separate hearing. Thus, it would make most sense for the 2010-2012 Phase I Cable Proceeding to be initiated first, thereby allowing the satellite claimants to follow past practices.


