**JOINT NOTICE OF FINAL SETTLEMENT**

Pursuant to *Public Order 2 For Further Distribution Phase Proceedings*, issued by the Copyright Royalty Judges (“Judges”) on July 1, 2025, the Devotional claimants represented by the Settling Devotional Claimants (the “SDC”) and the Devotional claimants represented by the National Association of Broadcasters (“NAB”) jointly file this notice of final settlement of previously identified controversies regarding the distribution of 2014-2017 cable royalties within the Devotional category.

SDC and NAB have reached a confidential settlement that fully resolves their outstanding 2014-2017 cable controversies in the Devotional category. Accordingly, NAB will not pursue any claims in the Distribution Phase proceedings to determine the intra-category distribution of 2014-2017 Devotional category cable royalties.
