**MULTIGROUP CLAIMANTS' AND SPANISH LANGUAGE PRODUCERS'
NOTICE REGARDING CATEGORY DEFINITIONS**

Multigroup Claimants (MC) and Spanish Language Producers (“SLP”), pursuant to the *Notice of Participants, Notice of Consolidation, and Order for Preliminary Action to Address Categories of Claims*, issued September 9, 2015 by the Judges, hereby notifies all participants of the following:

Although MC and SLP take issue with the program category definitions utilized in recent years by asserted Phase I parties, MC and SLP will not be initiating challenge to the program category definitions utilized by various parties for the 2010-2013 calendar years due to the perceived mootness of such issue. Notwithstanding, in the event that such program category definitions are proposed to be adopted as part of a rulemaking proceeding applicable to calendar years beyond 2010-2013, MC and SLP shall challenge the program category definitions utilized in recent years on the grounds that such definitions fail to organize programming according to the stated precept for seeking commonality of interest amongst the producers of such programming.
