<u>DIRECT TESTIMONY OF JOHN MORRIS ON BEHALF OF</u> <u>COLLEGE BROADCASTERS, INC.</u>

- 1. My name is John Morris. I currently serve as the President of College Broadcasters, Inc. ("CBI"), a 501(c)(3) corporation. I submit this written testimony in support of the SoundExchange, Inc. and CBI's Joint Motion to Adopt Partial Settlement.
- 2. CBI is a national nonprofit association, the members of which include college, university and high school radio and television stations and other electronic media organizations. Many of CBI's radio station and other members make internet transmissions subject to licensing under 17 U.S.C. §§ 112(e) and 114.

Personal Qualifications

3. I was elected President by the membership of CBI in 2016. Prior to my election, I served as an active member of CBI for over 15 years. In that time, I have presented on dozens of panels during the organization's National Student Electronic Media Convention discussing a variety of topics. Before being elected to the CBI Board of Directors, I served on the Indiana Association of School Broadcasters Board of Directors for over a decade.

- 4. During my tenure at CBI, I have worked with nearly 100 college radio and media outlets that are primarily staffed by students.
- 5. I have had articles published in a variety of radio journals concerning CBI and student radio, as well as being a guest on podcasts hosted by the Radio Advertising Bureau and Radio Survivor to talk about college radio.
- 6. I am currently employed by the University of Southern Indiana ("USI") as an Instructor in Radio and Television and as General Manager of and Faculty Advisor to WSWI, USI's campus radio station. I have held these positions since August of 1999. During this time I have worked with our Broadcast Advisory Committee consisting of professional broadcasters as well as having the radio station named Student Organization of the Year.
- 7. Prior to my work in academia, I held positions in commercial radio sports, news, and sales at radio stations in Indiana, Idaho, and Missouri.
- 8. I hold a Bachelor of Arts from the University of Wyoming and a Master of Science from Indiana State University in Human Resources Development. I first became involved in student radio in 1982 at the University of Wyoming on KUWR.
- I have won three national awards for my work in radio. All are from the
 Broadcast Education Association Festival of Media Arts in Long Form Production and Broadcast
 News.
- 10. I have more than 18 years of employed and volunteer experience working in college radio and television stations that are staffed and run by students.
- 11. I have led CBI's efforts to obtain reasonable rates and terms for its members' webcasting operations since 2016. CBI has a long history of advocating on behalf of its member stations. As part of its efforts, CBI participated in three previous rate-setting webcasting

proceedings before the Copyright Royalty Board and has submitted comments to the Copyright Royalty Board on behalf of its membership.

12. My testimony is based on my experience in various roles at CBI and my experience in working with and mentoring student-staffed webcasting, radio, and television stations. My testimony is further based on the resources available to me and upon on which I rely to carry out my duties as President of CBI.

PROPOSED SETTLEMENT

- 13. The proposed rates and terms are attached to SoundExchange, Inc. and CBI's Joint Motion to Adopt Partial Settlement, which will be filed separately. The proposed rates and terms are similar to those currently codified at 37 U.S.C. 380.21-23, except that the minimum fee applicable to CBI's member stations will increase by \$50 per year throughout the settlement period.
- 14. CBI believes the proposed rates and terms to be reasonable because they generally maintain the existing regulations for CBI's member stations for the eligible nonsubscription transmissions and related ephemeral recordings they make over the Internet under Sections 112(e) and 114 of the Copyright Act.

Except as otherwise noted, I have personal knowledge of the facts in my testimony, and the foregoing is true and correct to the best of my understanding.
