JOINT PETITION TO PARTICIPATE OF PUBLIC BROADCASTING SERVICE

Public Broadcasting Service (“PBS”), on behalf of copyright owners of programs broadcast on U.S. noncommercial educational television stations that are retransmitted by cable operators (the “Public Television Claimants”), hereby submits this Joint Petition to Participate in response to the Copyright Royalty Judges’ Notice published at 89 Fed. Reg. 65,938 (August 13, 2024). PBS and the Public Television Claimants submit this Joint Petition to Participate in both the Allocation and Distribution Phases of this cable royalty proceeding for the years 2018, 2019, 2020, and 2021. A \$150 filing fee accompanies this filing.

PBS and the Public Television Claimants have a significant interest in the subject matter of this proceeding because they own or represent owners of copyrighted works broadcast on U.S. noncommercial educational television stations that were retransmitted by cable operators during the relevant period. PBS has served as the sole representative of the public television (“PTV”) claimant category in every cable royalty distribution proceeding since the 1978 proceeding and has received a share of the cable compulsory royalty funds for each year that the funds have been distributed.

The undersigned hereby certify that they have the authority and consent of PBS and the Public Television Claimants named in Attachments A, B, C, and D to represent them in this cable royalty distribution proceeding, as indicated.¹
